## Meeting started at 1:02PM

- 1. Review of FY 2024 Board resignations/term expirations
  - With LL's resignation, the bylaws were shared with Governance Committee. It was recommended that Richard Russell move up from Vice Chair to Chair, with John LaCivita moving from Secretary/Treasurer to Vice Chair and for the Governance Committee to make a recommendation on who from the BOD would move to the Secretary/Treasurer position. With LL's resignation we will now be looking for someone from healthcare, and Stacey Corley's name was mentioned and agreed she'd be a good candidate. She will also be added to the list to be considered. This will give us a good bench for the following year.
